Q1: WHERE IS MMASINACHI PHASE 2,?

Mmasinachi Phase 2 is located at Issele-Mkpetime, Asaba.

Q2: WHO ARE THE OWNERS/DEVELOPERS OF MMASINACHI PHASE 2?

O3: WHAT TYPE OF TITLE DOES MMASINACHI PHASE 2?

Q4: ARE THERE ANY ENCUMBRANCES ON THE LAND?
